GENERAL TERMS AND CONDITIONS - ALL PROGRAMS

Enrolling Your Child

Enrollment in all Trail Blazers programs is done online. Questions regarding program availability, enrollment, or waitlists should be directed to the Trail Blazers registration team at registration@trailblazers.org or 212-529-5113.

Securing Your Child's Place in Your Trail Blazers program

Your child's enrollment is not considered complete until a payment has been made towards his/her program. Payment amount varies by program, and can be flexible. All required forms must be submitted by the applicable deadlines.

Our School Break programs require payment at the time of registration. Our summer camp and after school programs require that payment is made by the deadlines established throughout the duration of each specific program.

Payment Plans

The availability of payment plans varies by program. Information about program payment expectations is given at the time of registration. By registering for a Trail Blazers program, you are acknowledging the payment expectations for your particular program, and agreeing to abide by those expectations.

Refund/Cancellation Policy

Program cancellation must be done 28 days prior to the first day of the program in order for a full refund to be considered. Program tuition is refundable on a pro-rated basis, after the 28-day cancellation notice.

Refunds or credits will not be given for unused program days or weeks while participating in the program, as staffing must be committed based on the number of children enrolled.

- Specific Information for School Break and Single Day programs: a full refund may be given for cancellation within 7 days (1 week) of the first day of each program.

- Specific Information for Under One Sky After School: refunds due to early departure from the program are given at the discretion of Trail Blazers and at a rate not to exceed 50% of the balance due for unused days.

Refund requests must be made in writing, either by emailing the program's director or emailing registration@trailblazers.org. You will receive confirmation that we have received your email within one week. Refunds requests are reviewed and processed within 3 months of notification.

Refunds are processed within 3 months of notification. Additional refund policies may apply to the program your child is participating in, and are applied at the discretion of Trail Blazers staff.

By enrolling my child in a Trail Blazers program, I understand:

- 1) That I am responsible to follow the payment schedule set forth for each program
- 2) That Trail Blazers reserves the right to cancel programs not meeting minimum enrollments;
- 3) That the Program requires my child to meet certain standards of behavior and that if my child fails to behave or demonstrates repeated unsatisfactory conduct, the Program has the right to dismiss my child from the Program, with no refund;
- 4) That the illegal use of drugs or alcohol is grounds for immediate dismissal and that smoking is not permitted;
- 5) That if my child is dismissed from the program, it is my responsibility to arrange to have him/her picked up immediately;
- 6) That in consideration of conducting the Trail Blazers After School Program and allowing my child to participate in such program, I hereby release and forever discharge Trail Blazer Camps and its officers, volunteers, employees, contractors, and agents from any liability arising out of or based upon any bodily injury or property damage which may be sustained by my child while participating in such program.

TERMS AND CONDITIONS - UNDER ONE SKY AFTER SCHOOL PROGRAM

By enrolling my child in an UOS After School Program, I understand:

- 1) That tuition payment is due as per the following schedule:
 - a. FALL PROGRAM:
 - i. Half tuition due September 1
 - ii. Paid in full by December 1
 - b. SPRING PROGRAM
 - i. Half tuition due February 1
 - ii. Paid in full by May 1
- 2) That some Program classes may involve trips outside the building supervised by staff of the Program. I give my child permission to go on any such trips organized as part of the Program, including (but not limited to) neighborhood libraries, parks, museums, and other schools.

TERMS AND CONDITIONS - OVERNIGHT CAMP

By enrolling my child in a Trail Blazers overnight camp program, I understand:

- 1) That tuition payment is due by June 1 of the participating year.
- 2) That some Programs may involve off-camp trips supervised at all times by Trail Blazers staff members, using such means of transportation as deemed necessary by the camp;
- 3) That this program includes active outdoor games and pursuits, including but not limited to hiking, fire building, and outdoor cooking; aquatic, lake-based activities, including but not limited to swimming, canoeing, and fishing; and adventure-based pursuits, including use of a low ropes challenge course, which by definition is a series of group and individual challenges constructed of ropes, cables, wood, tires and either telephone poles or trees. All staff are trained and/or certified to facilitate these activities.
- 4) That I can opt to attend a pre-summer informational session or Open House.

Further Scholarships for Overnight Camp

A limited number of scholarships are available for Trail Blazers overnight programs and will be given on a first come first served as well as a need basis. Additional scholarship is available to families at all tier levels for one session of camp per child. To be considered, you must fill out an [online request form](#). All scholarship requests must be made through this form.

It is the responsibility of the parent/guardian to reach out to Trail Blazers within two weeks of registering for your program if additional scholarship assistance is required, otherwise it will be assumed that you intend to pay the total amount as per your self-selected tier.

In order for us to feel confident in offering additional scholarship assistance, families must demonstrate intent to pay. Trail Blazers reserves the right to revoke scholarships from families who neither demonstrate intent to pay nor communicate changing circumstances with the registration office.

Deposit Payments and Reallocation of Scholarships for Overnight Camp

A deposit payment is required within one month of registering for your program. This payment is made either by paying in full at the time of enrollment, or in electing to pay by an established payment plan.

If we do not receive payment within one month of enrollment, or by June 1, any additional scholarship previously agreed upon may be reallocated to another camper and your camper's spot will be made available to other families. In cases where scholarships have been reallocated, you may still be reconsidered for further assistance pending scholarship availability.

TERMS AND CONDITIONS – PLG BROOKLYN DAY CAMP

By enrolling my child in a PLG Brooklyn Day Camp program, I understand:

- 1) That tuition payment is due by June 1 of the participating year. After June 1, payment for the participating week is due at the time of enrollment.
- 2) That some Program classes may involve trips outside the building supervised by staff of the Program. I give my child permission to go on any such trips organized as part of the Program, including (but not limited to) neighborhood libraries, parks, museums, and other schools.
- 3) That I can opt to attend a pre-summer informational session.

Further Scholarships for Day Camp

A limited number of scholarships are available for Trail Blazers day camp program, to families for whom the tier 1 price is out of reach. Scholarship requests must be received through our [online request form](#). Requests received by April 15th will be considered, with additional scholarships determined by April 30th. All scholarship requests must be made through this form.

At Trail Blazers' discretion, a second round of scholarship requests may be done.

It is the responsibility of the parent/guardian to reach out to Trail Blazers within two weeks of registering for your program if additional scholarship assistance is required, otherwise it will be assumed that you intend to pay the total amount as per your self-selected tier.

Deposit Payments and Reallocation of Scholarships for Day Camp

A deposit payment is required within one month of registering for your program. This payment is made either by paying in full at the time of enrollment, or in electing to pay by an established payment plan.

If we do not receive payment within one month of enrollment, or by June 1, any additional scholarship previously agreed upon may be reallocated to another camper and your camper's spot will be made available to other families. In cases where scholarships have been reallocated, you may still be reconsidered for further assistance pending scholarship availability.

TERMS AND CONDITIONS – LEADERSHIP/LEADERS IN TRAINING

By enrolling my child in UOS Leadership/Leaders in Training, I understand:

- 1) That all terms/conditions for Overnight Camp apply to Leaders in Training/Internship program participants;
- 2) That my child may be required to undergo an in-person or phone interview in order to enroll in their program choice.

- 2) That some Program classes may involve trips outside the building supervised by staff of the Program. I give my child permission to go on any such trips organized as part of the Program, including (but not limited to) neighborhood libraries, parks, museums, and other schools.
